Les Glières Swimming Pool protocol for 2020 Summer

As expected, the access to the swimming pool will require **specific procedures**. On the one hand, in order to comply with the sanitary protocols from the French Government, on the other hand, to ensure users the best safety conditions and to avoid, if a Covid case is identified, the closing of our facility and/or quarantine measures.

Specific procedures:

These measures will imply the **hiring of a supervisor** for all the opening hours during this summer (from June 15th to September 15th – from 9:30 to 19:30).

NATIONAL REQUIREMENTS:

- Fulfilling « barrier measures » : personal hygiene and physical distance between users.
- Fulfilling a maximum attendance rate : 1 person for 4 m² of public access surface (pool beaches and terrace) (Covid rules)
- Closing of shower booths and toilets, with the exception of the footbath shower.

ACCESS WILL BE REFUSED TO ANYONE SHOWING OBVIOUS SIGNS OF DISEASE SUCH AS COUGH AND/OR FEVER

ADITIONAL REQUIREMENTS:

- Implementation of an **attendance log** (entries/exits) in order to identify persons allowed to have access to the pool. This log will be filled in with names, apartment number, number of persons, entry and exit hours. For the Supervisor, he will have an updated file with co-owners details in order to check access rights. This file will show the thousands index for each apartment and therefore the accommodation capacity as per a cross chart established by our co-ownership agent.
- Implementation of entry & exit lanes
- Allocation **of coloured wristbands** for each user. The purpose is not to limit attending time, but to allow the visual identification of first in users in case of high attendance and to avoid identification of users by names. These wristbands are to be handed back upon exit of the swimming pool; they will be sanitized after each use (bathed in a sanitizing solution).
- Users must compulsorily **show up wearing swimwear** at pool entry due to lack of dressing rooms.
- Users must compulsorily wash hands with disinfectant or soap, have a shower, go through the footbath before entering the pool area, even if do not intend to bath.
- No personal item such as large bags, seats, balls, flotation toys, will be allowed within the pool area. Only Tshirts, bath towels, pool gowns shall be admitted. Small items such as hats, books, sun glasses and sun cream, a small bottle of drinking water and mobile phones which can be carried in a small bag will also be admitted similarly to practices at the Bourg Saint Maurice municipal pool. Exemptions will be made for armbands for young children and also for a folding seat.
- No item should be left unattended at the pool by their owner's.
- Sinks and toilets of the technical shed will be closed since the national rules enforce disinfection every two hours, which is not achievable at the Glieres. Therefore, only apartment toilets are to be used.
- The Supervisor will be in charge of enforcing above rules **and** usual pool rules.
- All the above instructions will be displayed at the pool entry and therefore made known to all users.
- Children under 11 years of age are not allowed to have access to the pool if not accompanied by an adult.
