SWIMMING POOL RULES
(Pool without lifeguard watch)

OPENING HOURS: From 09:30 to 19:30

1/ SWIMMING POOL USERS ARE REQUESTED TO:

- 1) **Comply with last sanitary protocols (Covid) detailed hereafter**
- 2) Make sure pool and surroundings are kept clean
- 3) Compulsorily have a shower at the footbath before entering the pool area
- 4) Have a proper dressing and behaviour
- 5) Make sure the place is kept quiet for the neighbours by avoiding crying , and as parents, by keeping control over the children

2/ IT IS STRICTLY FORBIDDEN IN THE POOL AREA:

- To use balls, fins, boats, mattresses and other flotation toys except buoys, and flotation waists used to learn how to swim.
- To run around the pool
- To jump like « bombs » and other similar games
- To use transistor radios or similar items
- To have picnics
- To use the pool outside opening hours

3/ BECAUSE OF POOL LIMITED WELCOME ABILITY:

- Access to the pool is only allowed to the co-owners and to the tenants and their claimants
- It is absolutely forbidden to invite foreigners in the residence for the sole use of the pool. In the same way, juveniles cannot invite non resident friends
- The supervisor or the caretaker will rightly exclude any offender.
- Non-swimmer youngsters must accompanied by their parents
- The co-ownership is in no way responsible for any accident in the pool area and surroundings since the pool is private and without lifeguard watch.
- Users must take care of the facilities which belong to everyone.
- It is obvious that the pool is a place for bathing and rest, everyone's' behaviour must be appropriate to avoid hurting other users.
- Dogs are not allowed at the pool surroundings

COVID RULES:

- Showers, sinks and toilets of the technical shed are closed (except footbath shower) therefore, only apartment toilets are to be used.
- Fulfilling « barrier measures »: personal hygiene and physical distance between users.
- Fulfilling a maximum attendance rate : 1 person for 4 m² of public access surface (pool beaches and terrace)
- Implementation of an attendance log (entries/exits) in order to identify persons allowed to have access to the pool and to allow to request first in to leave in case of high attendance or outsiders to the residence.
- Implementation of entry & exit lanes
- No item should be left unattended at the pool by their owner's (seats, towels, bags...).
- Only small bags will be allowed within the pool area
- **Users must compulsorily show up wearing swimwear at pool entry** due to lack of dressing rooms and **wash hands with disinfectant or soap before having a shower at the footbath.**
- **Children under 11 years of age are not allowed to have access to the pool if not accompanied by an adult.**
